

## **'Wouldn't Swap it for the World' - TV Script**

**Beginning of the TV show**

**(Title Sequence introduction)**

### **Scene 1**

**Presenter:** "Hello everyone! Welcome to another episode of Mysteries and Surprises! Today, we have another guest who will tell the audience about their item they wouldn't swap for the world and the audience must figure out what the mysterious item is. I will ask my guest a few questions about the items origin and the VT will unveil what it is!"

**Presenter:** "Now! Let's introduce our guest of today, Sammy!"

**(Clapping in background)**

**Guest:** "Hello everyone! Thank you for inviting me today! "(Presenter Name)

**Presenter:** "How are you today?"

**Guest:** "I am very well thank you and I am glad to be here!"

**Presenter:** "That's great to know! Today, you are here to shows us the item that is very precious to you and the audience must figure out what it is".

**Guest:** "Yes! I hope the audience do their best to figure out what my item is!"

Presenter: "Right then, let's begin with a few questions so the audience have an understanding of the items origin story"

Presenter: "So, tell me Sammy? Where did you get your item from exactly?"

Guest: "To begin with, me and my family went on holiday to Florida and visited an iconic theme park. I went to a special area in the park that caught my attention. Next, I walked into a mysterious shop and my item was located at that mysterious shop."

Presenter: "Wow! One of Florida's iconic theme parks is a fantastic origin for your item!"

Guest: "Actually, I had to earn my item when I was at the mysterious shop too!"

Presenter: "That's very unusual and fascinating. How did you have to earn your item?"

Guest: "Firstly, I had to go through a trial to earn my item. Secondly, after I completed my trial I was then allowed to keep my item. Thirdly, it was a lot of hard work and determination to get it too!"

Presenter: "The origin of your item is making me very curious and interested. In addition, it's strange how you had to this trial to get your item. Could you provide me some details as I am excited to know more about your story?"

**Guest: "The trial I did at the shop was not normal and it was very strange too"**

**Presenter 2: "How fascinating? Could you explain your comment in more detail?"**

**Guest: "Certainly! The aim of my trial was to use other items and understand which one for me would work the best! One of the items I used suited me very well unlike the others. Eventually, it was the item that I decided to keep. Most of the other item's I actually used caused a mess in the shop! The shop owner was furious too!"**

**(Presenter's face is puzzled at this point)**

**Presenter: "This has to be the craziest origin story about an item I have ever heard!"**

**Guest: "To make you even more curious and excited. The trial I did at the shop actually parallels a scene from an iconic film franchise!"**

**Presenter: "Wow! My curiosity is raising higher now! Since your trial resembled a scene from a film franchise, does that mean your item's origin comes from this film franchise you have stated?"**

**Guest: "Yes, that is all the details I will give for now, my VT will give more hints about it."**

Presenter: “Okay then, figuring out your item will prove to be a challenge! Now, as part of today’s show we will now show Sammy’s VT and get more answers about his mysterious item”.

**(VT begins to role)**

## Scene 2

**(VT finishes)**

Presenter: “Your VT has given me and the audience more hints about your item. I now fully understand that your item’s origin is from this film franchise. “

Presenter: “Why did you choose to create this VT Sammy?”

**Guest: “I choose to create this VT because I was inspired to create it from the trial I did that resembled a scene from the film franchise. However I created it in my own unique way so the audience could get some other clues”**

Presenter: That was a very good response you just said. During the VT, it was based around the theme of magic too? Does this link to your item?

**Guest: “Yes there is a connection of the theme I choose for my VT and my item”.**

Presenter: “This is making me curious once again. However, you also wore some colourful clothing during your VT. Could you give me details, of why you wore that clothing in your VT? ”

**Guest: "Of course! The clothing I wore comes from the film franchise and a lot of the characters in this film franchise wear clothing that is similar to the one's I wore".**

**Presenter: "I think we almost have an understating of what your item is. We are now in the last moments of the show now, however, it is time to reveal Sammy's item and the VT will show us what it is!"**

**(VT Item reveal)**

### **Scene 3**

**Presenter: "Wow! I am surprised! So the item that is precious to you does magic and is from the iconic film franchise Harry Potter! I am excited and eager to know more about your item now!"**

**Presenter: "Why did you choose this item then Sammy"?**

**Guest: "The item I choose is very precious to me because when I visited Universal Studios, the Wizarding World of Harry Potter is a place I wanted to visit as Harry Potter is my favourite film franchise! Next, I walked into Olivanders Wand shop and performed the trial from the famous film scene in which Harry must use different wands until he gets one that suits him".**

**Presenter: "That was a great explanation of why you choose your item and how much it means to you. Now, I hope I get to do the trial you did and get my own wand!"**

**Guest: "I hope you do get your own wand!"**

**Presenter: "I will, definitely! Thank you for coming onto our show today Sammy and showing me and the audience your item."**

**Guest: "I enjoyed being on the show today, thank you for having me."**

**“Presenter: No problem I enjoyed today and I hope we get to see you very soon. Thank you for watching today’s episode and look forward to another episode of mysteries and surprises”.**

**Presenter: “See you next time!”**

**Guest: “Farwell everyone!”**

**(Audience claps)**
